Fiancî Meeting Statement to Accompany I-129F You should attach (or include in "Part 8, Additional Information") a personal statement, drawn up by the signatory U.S. citizen. This should explain how you two met for the first time, when and where you met in person assuming that you and your boyfriendé met in person, look for documents that will prove this fact. Documents from a neutral external source such as an airline or an owner are the best. Some possibilities they include: dated photos of you together copies of airline tickets (including boarding passes) that you have used to meet you copies of passports that show official stamps since you traveled to see each other, and credit card receipts that show you two spend money or stay at the same place and at the same time.
